Eligibility Criteria for Admission

A person who has passed S. S. Examination or equivalent thereof is eligible to apply for admission to undergraduate courses (U.G.) Science, Arts, Commerce.

Application for admission is not guarantee for selection. Admission shall be taken in all categories purely on merit basis.

01.) It is under rules that a student passing I.Sc. or I.Com Examination with atleast 43% marks (second division) in the aggregate may be admitted to MJC Course of any subject in Arts faculty provided that a seat for such a student is left vacant after admitting the I.A. students in the merit list. This relaxation to I.Sc., I.Com student simply qualify them for accommodation, provided seats are left out after accommodating the Arts faculty students, who have their first claim in the matter.

02.) Student selected for admission must get themselves admitted within time given to them, failing which, the seat offered to them may be given to a candidate next in order of merit.

03.) The number of seats in all the three faculties is fixed and no admission shall ordinarily be made beyond the sanctioned limit.

04.) The application form along with a copy of the prospectus of the college may be had from sales counter for **Rs. 300/-** during the working hours of the office on any working day.

05.) Admission in U.G. (Science, Arts & Commerce) shall be made on the basis of entrance test.

06.) Students Selected for admission will have to submit their Marksheets, S.L.C/C.L.C., Migration in Original.

07.) Every admitted student will have to submit 45mm x 35mm size, 4 copies of recent photographs for Identity Card and Library Card.

08.) Last date for admission to any of the course shall ordinarily be 3 weeks from the date of the publication of the qualifying examinations result. General extension may not be done if needed.

09.) Regular classes shall start within four weeks after the expiry of the last date of admission.

Open & Reserved Seats Of MJC

(i) **Open Seats:** Open Seats in History are 120, in Pol. Sc. Sc. 120 and in Sociology 100, while in Psychology and Economics open seats are 85.

(ii) Reserved Seats: Reserved Seats in each of the subjects of History, Pol. Science, Sociology, Psychology and Economics are 20. The reservation is made to encourage the less popular subjects. The distribution is given below.

General Rules of Students

01.) The new session starts in June and in January Semester wise every year.

02.) Tuition fee shall be chargeable from June irrespective of the date of admission.

03.) A consolidated default fine amounting to rupees sixty **(Rs. 60/-)** shall be charged for non-payment of tuition fee on the due date of fee collection.

04.) Last date for admission to any of the course shall ordinarily be 3 weeks from the date of the publication of the qualifying examination result. General extension may be done if needed.

05.) Every student shall have to abide by the rules and regulations of the college and of the University which may be amended from time to time by the concerned authorities.

06.) Identity Card :- Every student (Boy & Girl) must equip himself / herself with the college identity card without which he/she shall be deprived of such benefits and concessions as railway concession orders, access to office, class rooms, library, reading room, examination hall, laboratories, Principal's chamber etc. The College shall not take the responsibility of identifying such students who do not have their identity card with them.

07.) Non-collegiate students will also have to get their identity card prepared on payment of **Rs. 20/-** for the period when they attend classes or propose to appear at the examination.

08.) Students should be particular about their attendance as they will be solely responsible for its shortage.

General Rules of Office

01.) Separate office Counters are marked for different types of work, students should go to the correct counter and follow queue instead of coming in a disorderly manner.

02.) Perfect discipline and silence should be maintained.

03.) Application for specific purposes should be made in the forms prescribed along with fee (if any) payable for it. The requests shall be compiled as per rules and time schedule made of such work. All payments of tuition fee, Registration fee, examination fee etc shall be made through Challan of Bank of exact amount required to be paid Challan may be made from Indian Bank of any Branch.

04.) No Admission shall be taken without the orders of the authorities, (Adm-Committee, HODs, Principal). **NO ADMISSION SHALL BE MADE ON PART PAYMENT BASIS.**

05.) All queries shall be replied to on the enquiry counter as far as possible.

06.) Payment of scholarship etc. shall be made through cheque/transfer in direct the A/c. Such payments shall be made after being received from the proper source. Identification of the payee will be essential.

07.) Calculation of the daily attendance shall be made by the departmental assistant and countersigned by the H.O.Ds. Every student should compulsorily attend at least **75%** of lectures delivered in the class. **08.)** Admission of students of S.T / S.C / Back ward Annex-1, Staff ward etc. will be made against reserved quota fixed for each of them but that also shall be done according to merit. Their vacant seats will be filled by other deserving students as per decision of the authorities.

09.) Application for admission against reserved seats shall be submitted in special form along with the usual admission form.

Special Regulation for the girl students (As per current G.B's direction)

01.) Girl students shall be admitted in co-educational classes, as there is no separate shift / section for them. Girl's common room is provided separately.

02.) Girls students shall have to observe the following rules.

- (a) Girls are directed not to come in gaudy clothes in the college.
- (b) Girl students if they like may use black veils or reda or naquab of simple and sober colours.
- (c) Girls students should make arrangement of their conveyance themselves.

03.) After college hours the girl students are imperatively directed to go back to their residences.

04.) No girl student will be allowed to meet any unauthorised person, relatives / visitor / who may happen to call on her during college hours.

Note:

01.) Registration / Enlistment and Migration fee (if any) will be taken at the time of admission as per instruction of the University rules.

02.) All payment of the fees will be accepted through Bank Challan of Indian Bank of any Branch.

03.) The College authorities reserve the right to increase adm fees and charges at the commencement of each academic year if necessary.

04.) Fee once taken will not be refunded.

05.) No CLC shall be issued to newly admitted students within three months of admission except in special cases.

06.) The Students should retain their fee receipt to meet any discrepancies of Payment.

Financial Aid to Students

01.) Free studentship as provided under rules are awarded to 12.5% of the total number of admitted students, who are found deserving and disciplined. It can be withdrawn if the awardee is found to be undeserving or indisciplined.

02.) Help from P.B.F. is given to a very limited number of deserving students only once in a two year academic session, and records are maintained. Meritorious students may apply for merit-cum- poverty scholarship to the Government.

03.) Caste scholarships from Welfare deptt. are available to bonafide students of Backward communities, Schedule Caste, Schedule Tribes etc on giving application on time.

04.) National Scholarships may be available to deserving meritorious students from the Govt.

05.) Discretionary Grants of Vice Chancellor and Minister and M.Ps may also be available on application.

06.) Students offering Arabic, Persian, Home Science and Philosophy may apply for special Scholarship granted by the HODs of these Deptt. at their own level.

07.) All general financial concessions and help shall be granted by the concession committee and its decision shall be final, after approval of the Principal.

08.) No concession in Tuition Fee shall be allowed to service holder students. They may however be helped in special cases from P.B.F.

09.) Annex-1 B.C., Schedule Caste, Schedule Tribe students shall pay all other charges at usual rates excepting Tuition Fee which is reimbursed by the welfare department. Amount equal to T.F. and other charges if not paid earlier shall necessarily be deducted out of financial grants scholarships etc. (except book grant) when received in their names from any office.

10.) Mohammadan Education Committee, the parent body of the college reserves the right of recommendation for granting financial concessions to its nominees.

Special Concession

Ordinarily no special concession in tuition or admission fee will be given to staffward. The wards of class IV NTS & VBR staff of O.C. and M.A.A. school upto a limit of 2 wards of one employee may be given permissible concession only. (i.e. all charges be paid except the T.F.). Wards mean son, daughter, husband & wife of the employee.

All applications for concession of fee must be accompanied by an income certificate of the Guardian or a recommendation by a member of the governing body.

Ordinance for Admission

01.) This ordinance shall be known as "Ordinance for Admission" in the Bachelor of Arts / Science / Commerce for the Universities of Bihar including Patna University under CBCS System.

02.) The under graduate programmes shall be undertaken in eight Semesters spread over four years.

03.) It will come into effect from the Academic Session 2023-2024.

04.) The eligibility criterion for admission in Bachelor's programmes are listed in Table 1.

Table 1: Eligibility criteria for admission in Bachelor programmeUG SCIENCE

Candidates who have passed Intermediate examination I.Sc. or +2 Science Stream only of Bihar School Examination Board or equivalent examinations offered by other approved National/ State Boards.

UG COMMERCE

Candidates who have passed intermediate examination I.A./I.Sc./I.Com or +2 of Bihar School Examination Board or equivalent examination offered by other approved National/ State Boards

UG ARTS

Candidates who have passed intermediate examination I.A./I.Sc./I.Com or +2 of Bihar School Examination Board or equivalent examination offered by other approved National / State Boards.

05.) For the Current session 2023-24, University wise admission shall be made on the basis of marks obtained at 10+2 level by the Universities of Bihar including Patna University.

From the next academic year for all Universities of Bihar, admission to the first semester of the Bachelor programme shall be made, on unified basis, on the basis of marks obtained by the candidate at 10+2 level or Common Admission Entrance Test (CAET), as decided by the Chancellor.

1.1.) These regulations should be called the "Regulation of Examination" for the 04-Year UG programme of Universities of Bihar under the Choice Based edit System (CBCS) Curriculum.

1.2.) It shall come into force from the Academic Year 2023-2024.

1.3.) The B.A. (Hons) program shall come under the "Faculty of Arts", B.Sc. (Hons) under "Faculty of Science" and B.Com. (Hons) under "Faculty of Commerce".

2.) OUTLINE OF THE CHOICE-BASED CREDIT SYSTEM (CBCS):

It shall consists of following courses, Major Courses (MJC), Minor Course (MIC), Multidisciplinary Course (MDC), Skill Enhancement Course (SEC), Value Added Course (VAC), Ability Enhancement Course (Course on Disaster Risk Management) (AEC), Internship (INT), Research Project (RP) / Dissertation.

Program of Study/Course Structure

1.1.) Students shall undergo a certified program of study extending up to eight semesters spread over four academic years.

1.2.) Each academic year shall consist of two semesters: Odd semesters (I, III, V, VII) from July to December Even semesters (II, IV, VI, VIII) from January to June.

1.3.) The Bachelor programme will consist of a number of courses as per Annexure, spanning over eight semesters

3.5.)To maintain Uniform academic accountability, certain weightage is assigned in the form of "Credit", separately for each course per semester depending upon the length of the Curriculum. A minimum of 10 hours of teaching has been fixed for each credit as on average.

3.6.) The Bachelor programme shall have 160 credits altogether. The CGPA shall be awarded on the candidate's performance in all papers/courses.

3.7.) The syllabus of the programme may be revised as per the demand of different stakeholders by BOS and will be duly approved by the Academic Council.

4.) UG Courses offered by SWAYAM/MOOC related to MDC and Skill enhancement, not studied as core course/paper may be selected by the candidate with the approval of the Department.

Students undertaking UG course from SWAYAM/MOOC shall be eligible for credit transfer if he/she gets a certificate for successful completion from SWAYAM.

5.) Evaluation of Performance Under C.B.C.S.

5.1) Any student admitted to Bachelor programme and registered in the University shall be eligible to appear in the University Examination for each Semester only after securing 75% attendance both in theory and practical classes separately and was also passed in all CIA.

5.2) University Examination of each course in all semesters shall have two components.

i) Continuous Internal Assessment (CIA) of MJC, MIC, MDC, AEC & SEC containing 30 marks.

ii) End Semester Examination (ESE) of MJC, MIC, MDC AEC & SEC, VAC containing 70 marks.

- i. One mid-semester written tests (1x15)

- iii. Attendance and conduct

5.3) The CIA component of the Examination shall be conducted by the department under the concerned teacher of the course/paper. He/ She will be responsible for the submission of CIA marks after evaluation to the Head of the Department.

5.4) Only the End Semester Examination (ESE) shall be conducted by the University. For the theory courses / papers of 3 credits or more, there shall be a written examination of 3 hours duration. For theory papers of less than 3 credits, there shall be ESE of two hours duration. However, the ESE of Practical and Project Dissertation viva-voce shall be conducted in the respective department.

5.5) The evaluation of the Project Dissertation will also be based on CIA and the end-semester examination.

5.6 All such examinations shall be as per the provisions of the Examinations Board.

6. Examinations:-

6.1 The End-semester-Examination will be conducted by the University.

Question Paper Pattern will be uniform for all Universities of Bihar.

6.2) The Candidate's performance in the examination for the Bachelor programme shall be evaluated following the Uniform Grading System (Credits) formulated on the guidelines of UGC for the computation of Cumulative Grade Point Average (CGPA).

6.3) The examination of odd semester I, II, V and VII shall generally be held in November and December and that of even semesters II, IV,

VI and VIII in the month of April-May.

6.4) Paper Setting and Evaluation: For ESE, the paper setting and evaluation will be done by the teachers of the concerned subject.

6.5) The question papers for all courses of (i) AEC (ii) SEC & (iii) VAC will be of OMR based objective type.

7. Passing of Examinations and Promotional Rules:

7.1) There shall be no supplementary examination in any of the courses/papers in any semester.

7.2) The candidates who have been admitted to the First Semester of a four-year Undergraduate Programme in a session can be placed in the following categories based on their attendance in the Semester and performance in CIA.

i.) Those who have cleared the CIA and attended the required minimum percentage (75%) of attendance shall appear in the ESE.

ii.) Those who have not attended the required minimum percentage of attendance (75%) and not cleared CIA shall in no case be permitted to appear in the End Semester Examination.

7.3) An appearing at the End Semester Examination, the candidates can be placed in the following categories in the context of the declaration of the Semester Examination results.

i.) To be declared passed in End Semester Examination; a candidate must secure at least a 'P' grade as mentioned in Table-4 in each course/paper (including CIA and ESE).

ii.) A candidate may be promoted to next semester based on the following criteria as given in Table-3.

i.) Candidates shall have to clear their backlog course/paper (s) in the subsequent end semester examination of that semester whenever it is available.

ii.) The Final result will be published only after he/she has cleared all 160 credits and three more academic years can be given to clear all 160 credits.

iii.) Since it is a continuous evaluation programme, a student shall be awarded Semester Grade Points (SGPA) at the end of the first-semester Examination, and in the subsequent semesters till the fifth semester, and finally, in the sixth Semester the result will be awarded based on CGPA. No grade points will be awarded if there is any backlog present.

iv.) The promoted candidate/candidates will not be awarded any SGPA/CGPA till he/she clears all the backlogs.

v.) A promoted candidate, he/she fails in ESE, he/she shall retain his/her CIA score and will reappear in the ESE only of the semester whenever available.

vi.) Students undertaking any UG course from SWAYAM.MOOC as SEC or MDC shall be eligible for credit transfer if he/she gets a certificate for successful completion from SWAYAM/MOOC.

vii.) The candidate must clear the programme within maximum of seven years. Academic Council may give one additional year of relaxation in case of exceptional circumstance.

Note:-Special Provision:

Case of serious health problems and other strictly unavoidable circumstances, relaxation in required attendance might be condoned up to a maximum 15%.

8. Declaration of Result:

The Teacher/Examination Department shall use the following grading system: Result in the form of grade points consequent upon evaluation will be awarded in the following two manners-

I.) At the end of each semester which will be titled as Semester Grade Point Average (SGPA).

II.) At the end of the programme, which will be titled Cumulative Grade Point Average (CGPA). The explanations for publishing results in the form of Grade points is given in Table-5.
